

Huggins Credit Union 61st AGM Held as an in-person meeting with COVID-19 protocols in place

On Saturday, October 8th 2022, Huggins Credit Union held its 61st Annual General Meeting at the Grand Marquis Conference Centre, Roopnarine Compound, Corner Biljah Road & Caroni Savannah Road, Charlieville, Chaguanas, at 3:00 p.m.

It was an opportunity for members to question and compliment the performance of the Board, Supervisory, Credit and other committees 2021 reports.

Robin Samlalsingh, former president of the credit union, informed all in attendance of his decision to resign from the board.



Members in attendance also received their copy of the updated bye-laws.

ELECTION RESULTS FOR 2022 - 2023 PERIOD Supervisory Committee

Gailann Brathwaite and Glen Narine will return to serve on the supervisory committee. David La Borde will join the duo on the committee as the third member of the committee.

The members elected the three-member committee from a field of five nominees. Gailann Brathwaite got 55 votes, David La Borde received 45 votes and Glen Narine got 44 votes.



Ayanna Antonie 23 votes and Karina Anderson-Singh 20 votes will serve as the 1st and 2nd alternates, respectively.

Credit Committee

The updated Bye-Laws 30.1 (a) caused three members of the last committee, who are current members of the board, to be not eligible for re-election to the credit committee.

Bye-Laws 30.1 (a) states, 'The Committee shall consist of five (5) members elected by the members at each Annual General Meeting, none of whom shall be eligible to serve on the Board or Supervisory Committee.'

The members attending the AGM, elected from a field of 7 nominees, the following members to serve on the 2022/23 committee: Derrick Murray 57 votes, Sarah Durrant 52 votes, Narda Coker 44 votes, and Shalleen Wiltshire 42 votes.

The fifth member of the committee had to be decided between Carlene King and Wendy Inniss since they both received 37 votes. After a quick discussion, they both agreed that Carleen King will serve as the fifth member of the committee and Wendy Inniss will be the first alternate. Kelly-Ann De Castro with 25 votes will be the second alternate.



Board of Directors

The 61st AGM saw eight members volunteering of their time to serve on the Board of Directors. With Robin Samlalsingh resigning his position on the board, five director spots were now vacant.

The membership elected Randall Howe (53 votes), Edwin Martin (50 votes), Galene Gabriel (44 votes), Sharifa Constantine-Bristol (40 votes) to serve for three years, and Abbey Acosta (37 votes) will serve one year.



The alternates Akeen Matthews (28 votes) and Afeisa Wilson-Ince (23 votes) will serve one year.

Nicole Abdool and Afeisha Wilson-Ince both received 23 votes and had to decide among themselves who would serve as the second alternate.
